I request that Great Eastern Resort Management issue a season skiing/snowboarding pass to me.

I realize that skiing and snowboarding have categories of inherent risks that I MUST ASSUME if I participate in the sport. They include, but are not limited to, variations in weather, snow and terrain, ice, rocks and forest growth (above or below surface), bare spots, towers, utility lines and their components, and well marked or plainly visible snow making and snow grooming equipment. Collisions with other people and objects, or falls, can cause permanent, catastrophic injury or death. To enjoy skiing and snowboarding, I must know and be willing to accept the limits of my ability. I will read and heed all posted signs. I am requesting a pass knowing that I am accepting the inherent risks of the sport. I understand that acquisition of a pass does not imply that I can use all lifts and ski or snowboard all trails.

I understand that fencing, poles and/or flags, signage and covers on equipment or objects or other forms of marking devices are used by the ski area to inform me of the presence or location of a potential obstacle or hazard. These markers are not a guarantee of my safety and will not protect me from injury. It is a part of my responsibility under "Your Responsibility Code" to avoid all obstacles or hazards, including those that are not marked.

I agree that any legal dispute arising out of this agreement, my use of the equipment or my participation in the sport will be brought in either the general district court or the circuit court of Rockingham County, even though some other jurisdiction or venue may be more convenient to me. In the event any section of this release is found to be unenforceable, the remaining shall be fully enforceable.

Massanutten Resort will provide the best conditions possible, weather permitting. Massanutten Resort does not guarantee slope conditions or length of season.

WARNING: Under Virginia law, there is no liability for an injury to or death of a participant in a project activity conducted at this location if such injury or death results from the inherent risks of the project activity. Inherent risks of project activities include, among others, risks of injury inherent to land, equipment, and animals, as well as the potential for you to act in a negligent manner that may contribute to the injury or death.
